Scout Section

The Scout Section is run by the Scout Leader and usually at least one Assistant Leader. **All Leaders are volunteers** who give their time for free and receive special training for their role. The Leaders are responsible for planning and running a programme of activities and games at meetings and special events. All Leaders are DBS checked and will have completed ongoing Child Safeguarding training.

Scout meetings are held
every **Friday** evening
between **18:30 and 20:30.**

The Scout section is divided into Patrols of six to eight Scouts named after British birds. Patrol Leaders are appointed by the Leaders who feel they meet the requirements, have shown commitment and have a good knowledge of Scouting.

There is also a Senior Patrol Leader, who from the quarterdeck leads the young people in their drill, and helps oversee activities. The Senior Patrol Leader is always the most experienced and most dedicated Scout.

Associations

The Ramsgate Small Boat Owners Association kindly donates the use of their mooring for our boats as well as the use of their boating area in the outer Harbour. In return all Scouts become associate members of the group. This does not cost anything and is done under the care of 6th Ramsgate Royal Harbour Sea Scouts.

Activities

Being RN recognized means there are certain badges we are expected to complete as well as water activities, the challenge badges and everyday scouting. To fit all of this in we have a three-year rolling program. There are many indoor activities as well as trips to local places of interest and District run events.

From around mid-April to the end of October we try to get away from the confines of the Scout hall and carry out as many outside activities as possible. November to April we are based at our HQ and to break up the winter months, we usually have short weekend camps and hikes.

Water Activities

Water Activities are our main outdoor activity and are strictly controlled by our qualified leadership team. Scouts have the opportunity to try all the activities.

Any Sea Scout who cannot swim can still take part provided they are wearing the correct life jacket.

Land Activities

Land activities are a major part of Scouting. We try to organise one main camp each year. Short weekend camps are normally undertaken during the winter months and hikes are carried out all year from four to twenty miles.

Church Parades

There are only two Church Parades which we expect all Scouts to attend. One is St George's Day, which is organised by the District and takes place in April at the Winter Gardens, Margate. The other is Remembrance Day in Ramsgate in November which takes place in St George's Church, Ramsgate.



Uniform

All Sea Scouts are expected to wear full uniform once they are invested, as follows:

- Hats – white with 'Sea Scout' Tally Band,
- Neckerchief – white, rolled and pressed,
- Jumpers – blue 'Sea Scout' jumper,

- Trousers (or skirt if preferred) – smart black*,
- Socks (or tights if skirt worn) – black, and
- Shoes – smart black*.
- Scout Belt

**Black trousers / skirts and shoes can be those worn for school, however where some schools accept black trainers these are not acceptable for Scout uniform*

Navy Blue Sea Scout jumpers and Scout belts can be bought online from the Scout shop: The neckers, woggles, and the hat talibands can be purchased from the leaders at a small cost. Please also see the Order Form later in this pack.

The **Royal Navy Caps** are ordered from Naval Stores and cost around £20. To buy, you will need to send a letter providing your child's head measurement in centimeters. Please obtain the details from the leaders.

We also ask that all Scouts bring a **complete** change of clothing for the evening's activities, so that their uniforms will remain clean and undamaged.

We recommend:

- T-shirt/jumper
- Old jogging bottoms/trousers
- Trainers
- Old coat

Membership Cost

Our Group is completely volunteer run and none of our Leaders or Executive Members are paid for their role. However, running a Sea Scout Group is very expensive and, although we do everything in our power to keep costs as low as possible, we do have relatively high running costs compared to land-based Scout groups because of our boats. 'Subs' include the following components;

- Scout HQ Membership Fee (covering insurance, resources and information etc.);
- Section/Group running costs; Books, certificates and badges;
- Leader training and specialist skills; and
- a contribution to our running costs/rent.

For convenience subs are paid on a monthly basis. The monthly membership fee is currently **£15**. This should be paid by a monthly standing order directly from your bank account on a date of your choice. This ensures that the Young Person is recorded as a member of the Scout Association and that insurance cover is valid. A standing order form is included with this pack and is *our preferred method of payment*. Alternative methods of payment (such as cash or cheque) should be discussed with your Section Leader and agreed in advance. We also encourage you to complete a Gift Aid Form, however you choose to pay your subs, as it enables us to claim extra money from the government at NO additional cost to you.

If subs are not received within four weeks of becoming due, the Executive Committee reserve the right to refuse admission of any Young Person until subs are paid. Subs are reviewed annually; changes will be given in writing to parents/carers at least two calendar months before the revised subs are due.


On occasion, the Group may be able to offer financial assistance. The Group will consider such circumstances on a case by case basis and discussions will always be in confidence.
